- Develop and maintain frontend features using Blade templates, SCSS, and jQuery.
- Build and optimise backend components, including models, controllers, migrations, and API endpoints.
- Write and maintain unit tests to ensure code quality and functionality.
- Collaborate with internal stakeholders to implement new features and improvements.
- Participate in code reviews and contribute to continuous improvement in the development process.
- Demonstrate strong experience in Git, including branching strategies, conflict resolution, and maintaining code integrity across multiple environments.
- Manage and deploy application updates via Bitbucket CI/CD pipelines.
- Work in an agile environment, providing input during sprint planning and retrospectives.
- Troubleshoot and resolve issues in both development and production environments.
- Contribute to the onboarding of new team members and provide mentoring to junior developers.
